WELCOME AND INTRODUCTORY REMARKS:

Chair Hay called the meeting to order noting that the press had been notified as required by the Freedom of Information Act.

He noted that Trustees John Busch, Frank Gadsden, Henrietta Golding, Greg Padgett, Renee Romberger, Craig Thornton, Ricci Welch, and John Wood will participate by conference call.

He welcomed everyone and noted that they will continue moving forward this morning in response to President McConnell's announcement last week regarding his plans to retire.

As Chair Hay stated last week, "President McConnell has done an exceptional job in his role leading the College of Charleston. We are all proud of the work he and his leadership team have done and the strong foundation that he has built for which future generations of students, faculty, staff, alumni, and community leaders will benefit.

Being a university president is no easy task, and President McConnell has done an excellent job serving and leading his alma mater. We are forever grateful for his thoughtfulness, his tireless work and the honor and integrity he brought to Randolph all.

The College of Charleston is an extraordinary institution of higher learning, and it is the task of this board to find its next extraordinary leader, and we will."

APPROVAL OF MINUTES:

It was moved by Trustee Cherry Daniel, and seconded by Trustee Demetria Clemons, that the minutes of the January 30, 2018 Special Board Meeting be approved as presented. The Chair called for the yeas and nays, and the Minutes were approved by voice vote.

EXECUTIVE SESSION:

The motion was made by Trustee Cherry Daniel, and seconded by Trustee Randy Lowell, to resolve the Board into Executive Session at 10:08 a.m. for the discussion of employment consistent with S.C. Freedom of Information Act [Section 30-4-70 (a) (1)]? All in favor.

For reasons of confidentiality in Executive Session, Chair Hay asked all Board members on the conference call to please acknowledge that they are on a phone line not being recorded and that they are in a private venue and alone while on this call. Trustees John Busch, Frank Gadsden, Henrietta Golding, Greg Padgett, Renee Romberger, Craig Thornton, Ricci Welch, and John Wood responded affirmatively.

At this point, Chair Hay noted that only the Board members, Mark Berry, Elizabeth Kassebaum, and Paul Patrick shall remain and attend Executive Session. He noted that Steve Osborne and Betty Craig are subject to the call of the Board, if needed, during this Executive Session and asked them to remain available and in close proximity to the Randolph Hall Board Room.

[Everyone not requested to attend Executive Session left the Boardroom.]

The motion was made by Trustee Demetria Clemons, and seconded by Trustee Randy Lowell, to come out of Executive Session at 11:18 a.m. All in favor.

[Regular session resumed and everyone returned to the Boardroom.]

Chair Hay noted for the record that no action was taken during Executive Session.

The motion was made by Trustee Henrietta Golding, and seconded by Trustee Joe Thompson, that based on advice of Legal Counsel, the Board of Trustees accepts President McConnell's letter in which he submitted his resignation effective July 2, 2018. All in favor.

The motion was made by Trustee Randy Lowell, and seconded by Trustee Demetria Clemons, to appoint Steve Osborne as the Interim President effective as of July 2, 2018, subject to the conclusion of mutually acceptable contract terms for that position. We look forward to

continuing to work with President McConnell and Steve Osborne during this search and the President's willingness to work in an advisory capacity after July 2. All in favor.

Steve Osborne's response: "I would like to express my appreciation for the confidence of the Board and state it is an honor to serve in this capacity, particularly as an alumnus of the College. I look forward to moving the College forward with a student-focused orientation. Again, I appreciate the support of all of you."

PRESIDENTIAL SEARCH PROCESS:

Renee Romberger, Search Committee Chair, spoke regarding the search process.

 Renee Romberger's remarks: "I appreciate your confidence in my leading the Search Committee. It is imperative to keep the Search Committee small with only eight members. Throughout the months of February and March, team leaders and co-leaders will schedule listening sessions to receive input from four stakeholder groups – faculty, students, staff, and donors/alumni."

While President McConnell's retirement marks the end of a remarkable career of public service to the State of South Carolina, it also represents a new beginning and another exciting chapter in the College's story as we look forward to celebrating the 250th anniversary of our founding in 2020."
