For the record, the Presidential Search Committee, chaired by Trustee Renee Romberger, was named to find the 23rd President of the College of Charleston to replace President Glenn McConnell who served as President from 2014-2018.

The Board of Trustees appointed Steve Osborne as Interim President effective July 2, 2018.

The College hired R. William Funk and Associates to oversee the Presidential Search. The Search Firm received over 100 applications. With the assistance of the Search Firm, the Presidential Search Committee narrowed the pool down to ten and then five candidates. The five candidates came to Charleston for interviews by the Board of Trustees. And finally, the Board of Trustees narrowed the pool to three candidates who came for on-campus interviews November 13-16, 2018.

During the on-campus interviews, the Board of Trustees met with each candidate for 90 minutes with the spouse joining the last 30 minutes of the interview.

The Board of Trustees will meet on Wednesday, November 28, 2018, to deliberate regarding the candidates. Consideration will be given to feedback received from various campus and off-campus constituencies regarding the candidates' interviews. A final decision regarding the 23rd President of the College of Charleston will be made public by the end of November or the beginning of December.
