#### **WELCOME**

Elizabeth Kassebaum, Executive Secretary for the Board of Trustees and meeting organizer for today's virtual meeting, welcomed everyone and turned the meeting over to Chair Hay.

Chair Hay called the meeting to order at 1:05 p.m. noting that the meeting notice has been posted and the press notified as required by the Freedom of Information Act.

Chair Hay welcomed Dr. Suzanne Austin, new Provost/Executive VP for Academic Affairs, to the meeting.

#### **EXECUTIVE SESSION**

### "BACK ON THE BRICKS" COVID-19 RETURN TO CAMPUS PLAN UPDATE

President Hsu provided an important update on the modified "Back on the Bricks" COVID-19 Return to Campus Plan. He announced that the College of Charleston will delay the start of in-person classes for three weeks until Monday, September 14. Classes will begin as scheduled on Tuesday, August 25, in an online environment.

The plan was to resume blended instruction with in-person and remote classes beginning in August, but the decision to delay in-person instruction until September 14 is a necessary step that will best protect and ensure the health and safety of our students, faculty and staff, as well as the greater Charleston community.

The College will delay move-in for residential students which was scheduled for August 20-23. New move-in dates and procedures will be announced soon by Campus Housing. Students will receive a prorated refund of the housing, dining and parking costs during these three weeks of fully online classes from August 25 until September 14.

Students who need to live in campus housing during the three weeks of online instruction will be able to apply for an exemption, therefore, requiring them to following strict face covering and social distancing protocols as outlined in the "Back on the Bricks" plan. They will not be eligible for discounted housing, dining and parking costs. More details regarding this exemption process will be provided to residential students by Campus Housing in the coming days.
